3. Approval of the Agenda – A. Nash moved, seconded by M. Kemp to approve the agenda. Motion carried 5-0.

PRESENTATIONS

The funds will only be used for teacher salaries and benefits. L. Rasmuson moved, seconded by D. Hefner to close Public Hearing and return to open session. Motion carried 4-0.
